CORE COMPETENCIES

Exterior cleaning of occupied commercial and institutional facilities, performed without disrupting building operations or tenant hours.

- **Building and facade washing.** Low pressure soft wash and pressure wash on brick, block, metal panel, EIFS, vinyl and stucco.
- **Window and glass washing.** Interior and exterior glass, storefront, curtain wall and hard water stain removal on ground and upper floors.
- **Roof cleaning.** Soft wash removal of algae, moss and organic staining on shingle and metal roofing, applied at manufacturer approved pressure.
- **Concrete and flatwork.** Sidewalks, entryways, loading docks, dumpster pads, parking structures and pavers, including oil and rust stain removal.
- **Fleet and equipment washing.** Trucks, trailers, service vehicles and heavy equipment, on site or at the facility yard.
- **Gutter cleaning and brightening.** Interior debris clearing plus exterior oxidation and tiger stripe removal.
- **Also:** rust and hard water stain removal, graffiti removal, wood and composite restoration (decks, docks, fencing, railings), and fountain restoration.

- **Owner performed work.** The person who quotes the job performs the job. No crew rotation, no subcontracted labor, one point of contact from walkthrough to signoff.

- **Wash water recovery.** Containment and reclaim of wash water on sites where discharge is restricted, which many federal and institutional facilities require.
